LETTER FROM THE EDITOR



LANDBANK approves PSALM P30B SHORT-TERM LOAN LINE

LANDBANK's biggest borrower to date, the Power Sector Assets and Liabilities Management Corporation (PSALM) met with the Bank's Agricultural and Development Lending Sector (ADLS) for the approval of a P30-billion Short-Term Loan Line. The approved amount will be used to augment PSALM's working capital as well as for its other funding requirements.

LANDBANK Executive Vice President for Agricultural and Development Lending Sector Edward John Reyes and PSALM Liability Management Department Acting Manager Manuel Marcos Villalon II signed the Credit Line Agreement. LANDBANK Senior Vice President for Corporate Banking Group Ma. Celeste Burgos and PSALM Finance Risk Management Division Chief Virginia Reyes served as witnesses.

Other representatives from LANDBANK Public Sector Department (PSD) and other PSALM officers were also present during the event.

PSALM was created on June 26, 2001 as a government-owned and controlled corporation by virtue of the Electric Power Industry Reform Act of 2001, or "EPIRA Law."

It is mandated to manage the orderly sale, disposition, and privatization of the National Power Corporation; (NPC) generation assets, real estate and other disposable assets, and independent power producer contracts. Its primary objective is the efficient liquidation of all NPC financial obligations and stranded contract costs.

BREAK GROUND FOR HOSPITAL EXPANSION

EVP for Agricultural and Development Lending Sector Edward John Reyes also recently led the groundbreaking ceremony for the expansion of San Juan Medical Center (SIMC) together with Senator Joseph Victor Ejercito, Mayor Guia Gomez, Vice-Mayor Janella Estrada and City Hall officials.

The City officials have seen the need to rehabilitate, re-equip and modernize the existing Medical Center to provide quality medical and diagnostic services to the constituents of the city.

The expansion of the Medical Center will increase its bed

capacity by 80 beds from the current authorized 150. The need is due to the increase in patient census especially those with intensive care needs in the City of San Juan.

The LGU has an approved term loan with LANDBANK amounting to P500 million to finance the construction, rehabilitation and site development of the San Juan Medical Center; acquisition of hospital equipment, furniture and fixture; as well as acquisition and installation of I.T. hardware, software and local area network.

TRANSFORMING OUR WATERS

◆◆◆ THE LANDBANK MANILA BAY SUNSET CLEAN-UP ◆◆◆

Leading the annual events for the 54th anniversary was the LANDBANK Manila Bay Clean-up activity held last August 12, 2017 along the catch basin area near the U.S. Embassy, Roxas Boulevard, Manila.

More than 1,900 volunteers from LANDBANK and Manila Bay SUNSET Partnership Program (MBSPPI) member organizations gathered to participate in the coastal clean-up held simultaneously with two other activities – the Polyethylene Terephthalate (PET) Bottle Rescue Boat Making and Mabuhay Balls Making.

Senator Cynthia Villar served as the keynote speaker during the event. Praising LANDBANK's active role in helping revive Manila Bay, she also introduced the latest MBSPPI project – the PET Bottle Rescue Boat Making.

Another highlight of the program was the turnover of

P176,880, a portion of the proceeds from the Manila Bay Fun Run last July 23, as organized by the Manila Broadcasting Company to help fund the clean-up operations.

Overall, event volunteers collected 2,575 garbage sacks during the clean-up, which filled up 16 garbage trucks.

MBSPPI also welcomed four new partners: Philippine Information Agency - NCR, Division of City Schools - Manila, Department of Finance, and the Asian Social Institute (ASI), which provided the technology for the Mabuhay Balls.



The PET Bottle Rescue Boats were introduced to MBSPPI by one of its partners, Villar SIPAG at Tiyaga Foundation, Inc., which redesigned the rescue boat to a size suitable for small waterways – made up of 700 pieces of recycled 1.5 to two-liter PET bottles. Which maybe used in cleaning waterways especially during typhoons and heavy rains to avoid further flooding. The PET Bottle Rescue Boat Making was developed by non-profit organization Tzu Chi Foundation.

New program partner Asian Social Institute (ASI) taught volunteers to make the Mabuhay Balls during the event. A graduate school and research institution that is based in Manila, ASI learned of this water cleaning technology of bokashi balls in 2007 through its affiliation with the Japan Asian Association and Asian Friendship Society. The term Mabuhay Balls, considered an offshoot of the bokashi balls, was used in introducing the technology to all the ASI partner communities in the country.

This helps improve water quality, promote the breakdown of organic and inorganic compounds, and prevent foul odor.

MMDA puts PET bottle rescue boats to the test

The MMDA will use the boats to conduct regular cleaning of the esteros within Metro Manila. The boats were personally received by MMDA Chairman Danilo Lim at the Estero de Vitas in Tondo, Manila.

LANDBANK will be making more boats through its Volunteerific program, seeking PET bottle donations from both employees and partners.

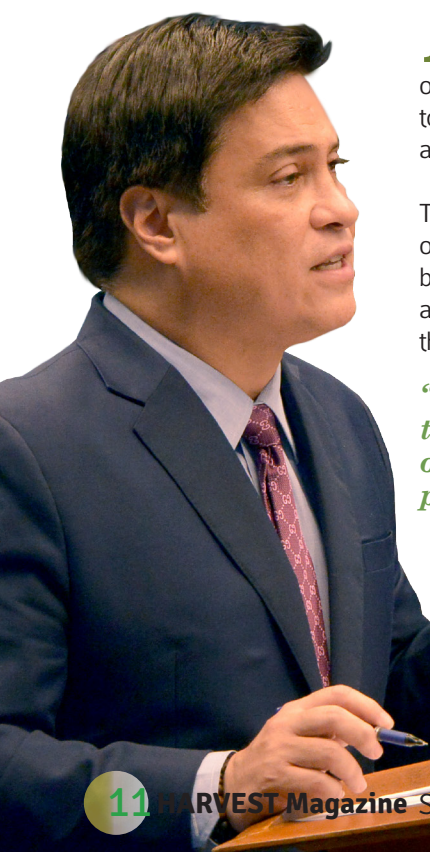

August 15, 2017 marked a milestone for one of the long-running programs of LANDBANK, the Gawad sa Pinakatanging Kooperatiba or Gawad PITAK, at the Senate of the Philippines duly recognized the year's program winners through the adoption of proposed Senate Resolutions 459, 460, 461, and 462. LANDBANK brings more ATMs to Luzon



Extending more banking channels outside of its branches, LANDBANK took to parts of Luzon to activate new ATMs in order to better serve its clients and partners in the region.

Off-site ATM in Cabiao, Nueva Ecija

Catering to the local government employees and general public alike, a new off-site ATM was activated by LANDBANK San Isidro (Nueva Ecija) Branch at the Cabiao, Nueva Ecija Local Government Unit (LGU) compound.

The activation and ceremonial withdrawal from the ATM were led by Cabiao Mayor Ramil Rivera together with other officials, and Officer-in-Charge for LANDBANK San Isidro Ernesto Jimenez.

In late 2016, a proposal was undertaken for LANDBANK to branch out in Cabiao, a first class urban municipality in Nueva Ecija. It is located at the south-western part of the province bordering Pampanga. Given its strategic location and business-friendly environment, the town has become one of the fastest growing and booming economies in the province.

Also present during the simple event were Ma. Iris Renee Engaran of LANDBANK San Isidro Branch, and Rosauro Dilig of Cabanatuan Cash Operations Unit who delivered the cash and assisted in the activation of the ATM.



First LANDBANK ATM Direct Connect in Northern Luzon

LANDBANK recently installed the first ever ATM Direct Connect facility for the Rural Bank of Cauayan, Inc. in Cabagan, Isabela, last June 1, 2017.

The ATM Direct Connect is a facility being offered by the Bank to Partner Institutions who wish to provide ATM services in their areas using the ATM provided by the Bank and the switch provided by BancNet.
