INVESTMENT OBJECTIVE AND STRATEGY

As a Dollar-denominated Bond Fund, the LANDBANK Global \$ Fund aims to provide relatively higher income through investments in Dollar-denominated fixed-income securities issued by the National Government and by local companies. Ideal for moderate investors who are willing to take on minimal risks for better returns.

CLIENT SUITABILITY

A *client profiling process* should be performed prior to participating in the Fund to guide prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Clients are advised to read the Declaration of Trust/Plan Rules of the Fund, which may be obtained from the Trustee, before deciding to invest.

The LANDBANK Global Dollar Fund is classified as a Bond Fund suitable only for investors who:

- Have a Moderate risk profile
- Can accept the risk that the principal investment can be lost in whole or in part when the NAVPU at the time of redemption is lower than the NAVPU at the time of participation.
- With an investment horizon of 3 to 5 years.

KEY RISKS AND RISK MANAGEMENT

You should not invest in this Fund if you do not understand or are not comfortable with the accompanying risks.

Credit Risk/Default Risk. The risk of losses due to a borrower's failure to pay principal and/or interest in a timely manner on instruments such as bonds, loans, or other forms of security which the borrower issued.

Reinvestment Risks. The risk associated with the possibility of having lower returns or earnings when maturing funds or the interest earnings of funds are reinvested.

Interest Rate Risk. This is the possibility for an investor to experience losses due to changes in interest rates.

Market/Price Risk. This is the possibility for an investor to experience losses due to changes in market prices of securities.

- The Fund implements a risk management policy that applies the principles of Value-at-Risk (VAR) and Modified Duration. VaR is defined as a statistical estimate of the amount of loss that an "open" risk position is unlikely to exceed during a given time period with a given level of confidence. Modified Duration is a means to measure the change in the value of a security in response to a change in interest rates. The formula is used to determine the effect that a 1% change in interest rates will have on the price of the bond.
- The Fund's investment outlets have been subject to proper screening and evaluation in accordance with LANDBANK – TBG's accreditation process and minimum regulatory requirements.

REDEMPTION CONDITIONS

Surrender of the Confirmation of Participation; subject to penalty if redeemed before the minimum holding period. For Partial Redemption, remaining balance should not be less than minimum investment.

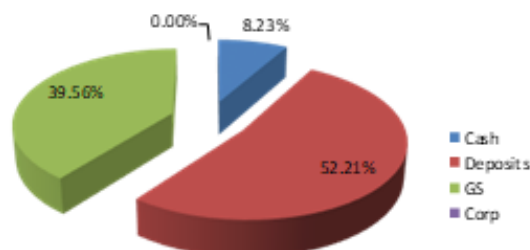

RELATED PARTY TRANSACTIONS

The Fund has deposits with LANDBANK amounting to \$37,723.91, which is within the limit approved by the Board of Directors. Likewise, related parties transactions are conducted on an arm's length basis.

FUND MANAGER'S REPORT

The Federal Reserve cut its policy rate by 25 basis points to a range of 1.75 – 2.00% as widely expected in the September FOMC meeting. The statement was little changed from the previous meeting with the perceived strength of the labor market and moderate economic activity. However, business spending was downgraded while exports weakened. Uncertainties in the outlook still remain while investors stay eager for meaningful progress from the U.S.-China trade front. Meanwhile, recent economic data has illustrated a contracting manufacturing and services sector and slowing jobs growth in the U.S. This added to the concerns of slowing international trade undermining the expansion of the American economy. Future Federal Reserve monetary policy will largely depend on how the economy evolves, and if it does turn down, the Fed could consider a more extensive path of rate cuts. This will induce U.S. treasury yields to stay low and Philippine dollar bonds to drop along in line with the lower global interest rate environment.

VIEW STRATEGY

The Fund strategy is to maintain current positions weighted in short-term deposit placements and ROPs to protect the Fund from further volatility brought about by global market issues.
