NON-DISCLOSURE/ CONFIDENTIALITY AGREEMENT

Under this confidentiality agreement, the Contractual agree that any such information will be treated with the utmost confidentiality, and that the Contractual/ representatives will use reasonable efforts to protect such information in their possession. The Contractual agrees that such information shall not be disclosed to third parties without prior written consent of LandBank, and that the Contractual will exercise the same degree of care as it applies to protect its own Confidential Information of similar nature that it does not desire to publish, disclose, or disseminate. Moreover, disclosures of such information shall be restricted to those individuals who are directly participating in the _____. In case of breach by the Contractual of any of the provisions in this Agreement, the Bank reserves the right to avail of any or all legal remedies available to it.

This agreement shall remain in effect and shall apply to all propriety or confidential information unless the information has been made available to the general public without restrictions by the LandBank of the Philippines.
