Supply and Derivery of 18 Units Laptop Computer

- The LAND BANK OF THE PHILIPPINES (LANDBANK), through its Corporate Budget for the contract approved by the Board of Directors for 2019 intends to apply the total sum of One Million Four Hundred Fifty-Seven Thousand Three Hundred Seventeen Pesos Only (PhP 1,457,317.00) being the Approved Budget for the Contract to payments under the contract for the Supply and Delivery of 18 Units Laptop Computer/ LBP-HOBAC-ITB-GS-20200305-01. Bids received in excess of the above ABC shall be automatically rejected at bid opening.
- 2. The LANDBANK now invites bids for the Supply and Delivery of 18 Units Laptop Computer. Delivery period is indicated in Section VI, Schedule of Requirements. Bidders should have completed, within the last five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to R.A. 5183.
