

1.	TERMS OF REFERENCE	Is it possible that we shorten the 48 runs? Can we have around 200-300 employees in one run or one session? We have enough laptops to cover remote drug testings. Based from experience, our staff can handle more than 200 employees in a day.	As stated in our approved terms of reference , the requirement is 48 runs for 2 years or 2x a month is estimate to cover the LANDBANK Plaza employees. This estimate has been studied taking into consideration but not limited to the following: - LANDBANK'S COVID 19 protocol - Testing site
2.	TERMS OF REFERENCE	Have we settled that the drug abuse awareness and prevention lectures be conducted via online?	As indicated in the Terms of Reference, II. Scope of Responsibilities, 6. " <i>Conduct of Drug Abuse Awareness and Prevention Lectures/Drug Test Orientations to be conducted at worksite or via online platform.</i> "
3.	TERMS OF REFERENCE	Regarding the delivery of service, will it just be done in LBP Plaza in Malate and/or in the drug testing laboratory premise? We don't have to go to the branch location, e.g. provincial branches?	The procurement for the Drug Testing Services is only for LANDBANK Plaza-based employees, hence testing will only be done at the LBP Plaza.
