

**CONTRACT AGREEMENT FOR THE  
TWO (2) YEARS SHARED CYBER DEFENSE SOLUTION**

**HOME DEVELOPMENT MUTUAL FUND (Pag-IBIG Fund)**, a government financial institution created and existing by virtue of and pursuant to Republic Act No. 9679, with principal office address at Petron Mega Plaza, 358 Sen. Gil J. Puyat Avenue, Makati City, hereinafter referred to as the "**ENTITY**", and represented in this act by its Chief Executive Officer, **MARILENE C. ACOSTA**, duly authorized for the purpose;

**TRENDS & TECHNOLOGIES, INC.**, a corporation duly organized and registered in accordance with Philippine laws, with principal office address at 6<sup>th</sup> Floor Trafalgar Plaza, 105 H. V. Dela Costa Street, Salcedo Village, Makati City, hereinafter referred to as the "**SUPPLIER**", and represented in this act by its Sales Manager, **MARY ROSE S. HERNANDEZ**, duly authorized for the purpose;

**WHEREAS**, the Entity invited Bids for certain goods and ancillary services, particularly Two (2) Years Shared Cyber Defense Solution and has accepted a Bid by the "**SUPPLIER**" for the supply of those goods and services in the sum of **One Hundred Fifty-Nine Million Seven Hundred Ninety-Six Thousand Pesos (PhP159,796,000.00)** allotted for 10,000 endpoints, inclusive of all applicable taxes, hereinafter called "the Contract Price".

**NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:**

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

In consideration for the sum of **One Hundred Fifty-Nine Million Seven Hundred Ninety-Six Thousand Pesos (PhP159,796,000.00)**, inclusive of all applicable taxes or such other sums as may be ascertained, **TRENDS & TECHNOLOGIES, INC.** agrees to deliver the Project entitled "**SHARED CYBER DEFENSE SOLUTION**" for a period of two (2) years in accordance with his/her/its Bid.
  4. The **HOME DEVELOPMENT MUTUAL FUND (Pag-IBIG Fund)** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
