1.	Is the certification as provided sufficed on the requirement of Letter of Credit?	•	No. Section 23.4.1.5 of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, provides that:	
2.	Is it possible that only the net amount of which cannot be covered by our NFCC be the amount covered by the letter of credit or if NFCC is not sufficient, we should get a letter of credit automatically amounting to the 10% of the ABC?		"If the bidder submits a committed Line of Credit, it must be at least equal to ten percent (10%) of the ABC to be bid: Provided, That if the same is issued by a foreign Universal or Commercial Bank, it shall be confirmed or authenticated by a local Universal or Commercial Bank."	
3.	We would like to confirm if supply of armored car be solely compliant on the SLCC with similar nature.	•	No. A contract is considered similar to this project if the same involves leased armored vehicle services for a commercial bank completed within the period of not more than five (5) years prior the opening of bids, per Clause 5.3 of the Bid Data Sheet.	
4.	Is it possible for us to provide SLCC per lot?	•	Yes. However, one (1) completed contract with amount equivalent to at least fifty percent (50%) of the lot with the highest ABC will suffice as compliance for the other lots.	
5.	If it is amenable to add paragraph on your provided Secretary's Certificate format for a Joint Venture as attached.	•	No. Secretary's Certificate and Joint Venture Agreement are two (2) separate requirements.
