

1.	Machine Design: Portable Currency Machine capable of counting, counterfeit detection of Philippine Peso & US Dollar Notes and printing of Serial Number with ADJUSTABLE MOBILE CARRIER/BENCH and printer.	May we clarify if Adjustable Mobile Trolley be accepted for the requirement.	➤ It must have a design where we can place the machine within seat level height.
2.	Shutter: Equipped with Automatic Noise and Dust Proof Shutter.	May we request to LBP to consider and accept. Equipped with Noise and Dust Proof Shutter (Manual Shutter).	➤ We need a machine equipped with automatic noise and dust proof shutter It is more user friendly and lessen manual intervention while using the machine.
3.	Performance: Item 2. The product must have a Certificate of Satisfactory Performance (CSP) from at least three (3) of the following; a. CSP from any three (3) Bangko Sentral ng Pilipinas (BSP) offices OR b. CSP from any three (3) of the top ten (10) banks in the Philippines based on assets that can be found in BSP website.	May we request that LBP to relax the requirement and include as item c; a. CSP from any two (2) Bangko Sentral ng Pilipinas (BSP) offices OR b. CSP from any two (2) of the top ten (10) banks in the Philippines based on assets that can be found in BSP website OR c. CSP from any three (3) of the bidders regular clients in the Philippines.	➤ This specification is to determine the integrity and high-quality performance of the products being at par with BSP's standards and with the banking industry as well.
4.	Feeder Capacity: Minimum of 2,000 banknotes continuous loading.	May we request the following to be accepted; Feeder Capacity: Range of 1,000 to 2,000 banknotes continuous loading.	➤ This specification is based on the volume of banknotes that we process for more efficient result.
5.	Operating Conditions: Operating System Windows 10 or higher	May we clarify and confirm with LBP to accept that our machine uses LINUX but it is compatible with Windows 10 or higher version.	Windows 10 or higher ➤ If OS is internal/built-in or embedded in the machine, Windows 10 or a higher version is required.


