

Item No. 12	Must be centrally controlled by an SDWAN controller.	May we confirm if you already have an existing SDWAN controller? If yes, could you please confirm who the existing provider is? Do we need to integrate the proposed routers into the existing setup?	Yes, we have an existing SDWAN controller. It is not necessary to disclose the existing SDWAN controller since the proposed controller need not to integrate with the existing.
Item No. 17	Should be able to support a mechanism wherein for every group of four (4) packets, it will send extra "parity" packets to recover lost packets on a link.	May we recommend considering Zone-based firewall, IPsec VPN, DMVPN, FlexVPN, GETVPN, as this will provide robust security, scalability, and ability to address packet loss through existing protocols like TCP and advanced VPN features. This approach simplifies deployment, improves performance, and avoids the overhead of additional parity packet processing.	We will retain with the requirement.
Item No. 18	Must perform certificate authentication prior to join the WAN system. The control plane to the controller must be encrypted with DTLS, TLS 1.2 or equivalent	May we kindly request for considering AES for WPA2; 802.11r standards support; 802.1X, RADIUS, AAA support. Item No. 74	Three (3) years warranty with on-site technical support, parts/equipment replacement. During the 3 years warranty period the Bidder must provide Landbank access to Technical Assistance Center (TAC) or its equivalent. Warranty must also covers any reconfiguration/integration after successful implementation.	Will this be done/performed by IBM/Cisco or LBP IT Team and IBM/Cisco will assist. All 600 routers will be delivered in FONMD Landbank Plaza Building.
