"If the Procuring Entity allows the submission of bids through online submission or any other electronic means, the Bidder shall submit an electronic copy of its Bid, which must be digitally signed."	a. In relation to this, under the Invitation to Bid issued for the AKAP NCR Bid, bidders are required to submit their bids "electronically on or before 10:00 A.M. deadline on February 18, 2025". Thus, it appears from both documents that the bids will be electronically submitted, and thus, must be digitally signed. Is the electronic signature used in Adobe considered as digital signature?	Yes, the bids must be electronically submitted. The bid documents must be digitally or electronically -signed. However, the GI-BAC allows submission of scanned documents bearing the wet-ink signature of authorized signatory/ies, subject to submission of original copies when required in the course of post-qualification. Yes, electronic signature using Adobe application is considered as digital signature.	
		b. Do you require that the electronic copy of a document be encrypted using software, such as DocuSign, which provides encryption for verification and authentication?	No.
