

20. Certificate of Satisfactory Performance:

- a. For New Bidder:
 - Certification of Satisfactory Performance issued in 2024 by at least three
 (3) universal/Commercial banks in the Philippines with which the bidder has ongoing or completed contracts from 2022 to 2024.
- b. For Existing Suppliers (both for Scheme or Non-Scheme cards):
 - Certification of Satisfactory Performance issued in 2024 by at least two
 (2) Universal/Commercial Banks in the Philippines with ongoing or completed contracts for Card Production with Personalization or equivalent document/s from 2022 to 2024.
 - Notarized Self- certification with No Unsatisfactory performance with LANDBANK from 2020 to 2024
- 21. Bidder must submit proof of their completed largest single contract. Proofs shall be:
 - a) Copy of the contract or purchase order; or
 - b) Copy of official receipt or certification from bidder's clients that items have been satisfactorily delivered/accepted;
 - Subcontracting is not allowed. Card production transaction between entities belonging to the same parent group shall not be considered as sub-contracting;
- 22. Signed conformity to the agreement: Non-Disclosure Agreement. Data Sharing Agreement and Acceptable Use Policy;
- Post-bidding Documents/Requirements [The Lowest Calculated Bidder must submit the following documents/requirements within two (2) banking days upon the receipt of the Test Embossing File and updated RSA of the Bank (if applicable):
 - 1. Twelve (12) sample EMV cards.
- Post-Qualification Documents/Requirements The bidder may submit the following documents/requirements within five (5) calendar days after receipt of Notice of Post-Qualification:
 - Business Tax Returns per Revenue Regulations 3-2005 (BIR No. 2550 Q) VAT or Percentage Tax Returns for the last two (2) quarters filed manually or through EFPS.
 - 2. Latest Income Tax Return filed manually or through EFPS.
 - Original copy of Bid Security (if in the form of a Surety Bond, submit also a certification issued by the Insurance Commission).
 - Original copy of duly notarized Omnibus Sworn Statement (OSS) (sample form - Form No.6).
