## **INVITATION TO BID FOR**

### **198 Units of Fire Extinguisher (HFC- 236fa)**

1. The LAND BANK OF THE PHILIPPINES (LANDBANK), through its 2024 Corporate Operating Budget approved by the Board of Directors intends to apply the sum of **One Million Seven Hundred Eighty-Two Thousand Pesos Only (PhP 1,782,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for the **198 units of Fire Extinguisher (HFC-236fa)**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The LANDBANK now invites bids for the **198 units of Fire Extinguisher (HFC-236fa)**. The contract period is indicated in Section VI, Schedule of Requirements. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

4. Prospective Bidders may obtain further information and inspect the Bidding Documents by contacting **LANDBANK – Regional Bids and Awards Committee (RBAC) V** at the telephone numbers and address given below during banking days from 8:30 A.M. to 3:00 P.M.
5. A complete set of Bidding Documents may be acquired by interested Bidders on **May 15 to June 4, 2024** from **LANDBANK – Regional Bids and Awards Committee (RBAC) V** at the **3<sup>rd</sup> Floor LANDBANK Legazpi Branch Building, Rizal St., Legazpi City, Albay** upon payment of the non-refundable Bidding Documents Fee, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Five Thousand Pesos Only (PhP 5,000.00)**.


The Procuring Entity shall allow the bidder to present its proof of payment for the fees by presenting the Official Receipt issued by the LANDBANK Branch from

where the bidding documents were purchased upon the submission of the Bidding documents on the day of the scheduled opening of Bids.

The Bidding Documents may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PHILGEPS) through ***notices.philgeps.gov.ph***, provided that the Bidders shall pay the corresponding cost of Bidding Documents not later than the submission of their bids.

6. The LANDBANK will hold a Pre-Bid Conference on **May 23, 2024, 10:00 AM** at the **2<sup>nd</sup> Floor, Conference Room, LANDBANK Legazpi Branch Building, Rizal St., Legazpi City, Albay** and through face to face or virtual (Zoom link will be provided upon request of prospective bidder) meeting, which shall be open to prospective bidders.
7. Bids must be duly received by the RBAC Secretariat through manual submission at the **2<sup>nd</sup> Floor, Conference Room, LANDBANK Legazpi Branch Building, Rizal St., Legazpi City, Albay** on **June 4, 2024 not later than 9:00 AM**. Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
9. Bid opening shall be on **June 4, 2024, 10:00 AM** at the **2<sup>nd</sup> Floor, Conference Room, LANDBANK Legazpi Branch Building, Rizal St., Legazpi City, Albay**. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. The LANDBANK reserves the right to (a) reject any and all bids at any time prior to the award of the contract; (b) waive any minor formal requirements in the bid documents; (c) accept such bids it may consider to be the most advantageous and beneficial to the Bank; (d) declare a failure of bidding; or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
