- 1. In view of the two (2) failed biddings, the LAND BANK OF THE PHILIPPINES, through its Regional Bids and Awards Committee V, now invites PhilGEPS registered, technically, legally, and financially capable contractors to participate in the Negotiated Procurement for the Procurement of Services of a General Contractor for the Proposed LANDANK Pilar Branch Lite Building Construction Inclusive of Office Furnishing and Equipment (OFE), in accordance with Section 53.1 of the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
- 2. The LAND BANK OF THE PHILIPPINES, through the 2024 Corporate Operations Budget intends to apply the sum of TWENTY ONE MILLION TWO HUNDRED EIGHTY ONE THOUSAND NINE HUNDRED PESOS ONLY (Php 21,281,900.00) being the Approved Budget for the Contract (ABC) to payments under the contract for the Negotiated Procurement of Services of a General Contractor for the Proposed LANDANK Pilar Branch Lite Building Construction Inclusive of Office Furnishing and Equipment (OFE) ITN No. LBP-RBACV-0624-01.
- 3. Completion of the Works is required **within 225 calendar days**. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Negotiation Documents, particularly, in Section II (Instructions to Bidders).

The selection of the successful offer shall be based on the best and final offer that will be submitted on the set deadline by the BAC and which would meet the minimum technical specifications required.

- 10. Bid opening shall be on June 28, 2024 10:00 a.m at the 2nd Floor, Conference Room, LBP Building, Rizal Street, Legazpi City. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
