

LANDBANK LEGASPI ROTONDA SUB-COU RELAYOUT/ RENOVATION

1. The LAND BANK OF THE PHILIPPINES through the 2025 Corporate Operations Budget intends to apply the sum of **One Million Eight Hundred Ninety Thousand Pesos Only (₱ 1,890,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for the LANDBANK Legaspi Rotonda Sub-COU Relayout/ Renovation per ITB No. LBP-RBACV-0125- 004. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The LAND BANK OF THE PHILIPPINES now invites bids for the above Procurement Project. Completion of the Works is required within **135 calendar days** upon receipt of Notice to Proceed. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from LAND BANK OF THE PHILIPPINES- Regional Bids and Awards Committee V and inspect the Bidding Documents at the address given below during banking hours from 8:30 a.m. to 3:00 p.m.
5. A complete set of Bidding Documents may be acquired by interested bidders on **January 24, 2025** from given address and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Five Thousand Pesos Only (₱ 5,000.00)**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees by presenting the Official Receipt issued by the LANDBANK Branch from where the bidding documents were purchased upon the submission of the bidding documents on the day of the scheduled opening of bids.
6. The LAND BANK OF THE PHILIPPINES will hold a Pre-Bid Conference¹ on **February 6, 2025 10:00 a.m.** at the 2nd Floor, Conference Room, LANDBANK Legazpi Branch, Rizal St., Legazpi City through **face-to-face meeting** and **videoconferencing** via Microsoft (MS) Teams Application, which shall be open to prospective bidders. Interested bidders shall send a request email to lbprbacv@yahoo.com for the meeting link.
7. Bids must be duly received by the RBAC V Secretariat through **manual** submission at the office address as indicated below on **February 18, 2025 not later than 9:00 a.m.** Late bids shall not be accepted.

¹ May be deleted in case the ABC is less than One Million Pesos (PhP1,000,000) where the Procuring Entity may not hold a pre-bid conference.



8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 16.
9. Bid opening shall be on **February 18, 2025 10:00 a.m.** at the 2nd Floor, Conference Room, LANDBANK Legazpi Branch, Rizal St., Legazpi City. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

The LAND BANK OF THE PHILIPPINES reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
